	The sites' location within a valley makes it high risk for flooding. Pre-existing photo-evidence of flooding at the site supports this fact and highlights the likelihood of contaminated rain/flood water washing into the watercourse. The site is adjacent to a watercourse which creates a high risk of contamination from the planned stabling of horses on the site. Given the aforementioned risk of flooding, it is highly likely that contamination of the watercourse occurs due to solid and liquid waste being washed into the watercourse by rainfall. The risk of phosphate contamination due to the lack of drainage plan and absence of covered manure pile to manage any contaminated water means that the risk to the watercourse is compounded.
