The Trustees discussed promoting healthy recreation and agreed that a local fitness instructor should be contacted to let them know that the top part of the recreation ground is available for classes subject to proof of their own risk assessment(s) and public liability insurance. Cllr Humphreys is to investigate the installation of a drinking fountain. Registry of the land is to be investigated.
